Subject:

Request, pursuant to the law, for the imposition of sanctions on electoral subjects and candidates of political parties, competing in the Parliamentary Elections of April 25, 2021, for violations committed by them in relation to the financing of the election campaign*.

Legal Basis:

- Law no. 10019 dated 29.12.2008 Electoral Code of the Republic of Albania,
- Decision no. 9 dated 09.03.2021 of the Regulatory Commission "On the procedures of operation and maintenance of the portal, the procedures and deadlines of the administrative investigation of the claims, and the decision taken at their conclusion".

Honorable Mr. Commissioner,

The mission of the Coalition for Integration Reforms and Consolidated Institutions (KRIIK Albania) is that of protecting and guaranteeing human rights and freedoms, as well as the full dimension of human security through strengthening the rule of law, democratic governance, promoting activism and civic engagement, as well as the promotion of transparency and accountability of public and political institutions.

In addition to the experience of monitoring the electoral process since the adoption of the Constitution by referendum, KRIIK, after the electoral reform of July 2012, has started and built an uninterrupted monitoring experience in following the political-institutional processes, which directly or indirectly affect the integrity of electoral processes, offering, with an analytical approach, recommendations or suggestions for a more complete implementation of the law, in writing and in the spirit of constitutional principles, to ensure this integrity.

Under this approach, an uninterrupted monitoring, from October 2012 until today, is dedicated to the decision-making, conduct and activity of the Central Election Commission in the administration of the process, as well as the conduct and law enforcement of the CEC administration. Particular attention has been paid to and continuously monitored the financing of election campaigns and political parties, the reporting carried out by the latter, as well as the conduct and decision-making of the CEC in relation to it.

As you are aware, the process of the Elections for the Assembly of Albania of April 25, 2021, was monitored by KRIIK from September 2020, with the announcement of the election date by the President of the Republic, until January 2022 with the conclusion of all elements of an electoral process. The findings and recommendations were made public

through ongoing reports and statements of the process, as well as in the Final Report published on 16 February 2022.

In KRIIK's view, transparency, and control over the financing of political parties and election campaigns remains a major issue and challenge, which in the current context is vital to the security and democratic future of the country.

From the monitoring conducted on this issue during the parliamentary elections of April 25, 2021, KRIIK highlights the necessity of a decision of the Central Election Commission about the legal violations identified.

This decision-making needs to be taken not as a penalizing purpose, but as a clear legal obligation, in fulfilling the role, and the climate of law enforcement by independent institutions, as well as increasing the accountability of political actors for the implementation and observance of the law.

It is also suggested that, in addition to deciding on legal sanctions provided in cases of violations found and proven, the CEC draw public attention to political parties and candidates for the complete fulfillment of legal obligations, as well as advocate for the need for legal amendments that should be undertaken by the legislator, to make the mechanism of transparency and control available more efficient and complete.

In the framework of all the above and based on Decision no. 9 dated 9 March 2021 of the Regulatory Commission, which details the provisions of Article 92/5 of the Electoral Code, which gives third parties the opportunity to make denunciations regarding possible violations for the financing of political parties, electoral subjects or their candidates, and for which they are required to be subject to administrative investigation by the State Election Commissioner, KRIIK submits below, as an indication or denunciation, its findings during the detailed monitoring that has been carried out. For ease of reference, the following material is numbered.

A. GENERAL FINDINGS

- 1) The financial self-declaration reports of electoral subjects, whether from political parties or even from candidates included in their lists or independently, must be completed with maximum responsibility in each field and detail defined in the content of the constituent forms.

The tolerance shown by the CEC for accepting partially or totally incomplete reports, whether due to an understanding approach to the limits of law violation, or even a lack of prior control by the administration, should be reflected at least by drawing public attention from the CEC to political entities in keeping the spirit of law enforcement. There is also a need for an evaluation and improvement process of the abilities and skills of the respective responsible administration in the CEC.

The same approach applies to the reports of financial monitors and statutory auditors.

- 2) In its decision-making, the CEC should extend control and judgment, even in the nature of expenditures declared by political parties, especially to parties which have received funds from the state budget.

According to the Electoral Code, Article 2 point 28, “*Electoral campaign expenditures* shall be expenditures made by or on behalf of an electoral subject, including the candidates and / or its branches, or an independent candidate, for the purpose of promoting their campaign or thwarting the campaign of another subject, regardless of the date they are made.”

As the Electoral Code explicitly defines campaign expenditure as an expenditure of a party or candidate for election campaign purposes, regardless of the date on which it is made, declarations of payment of party arrears or non-campaign expenditure, should not be counted in the financial statements of their election campaign.

- 3) In the same logic, and based on the same principles of obtaining funds, and donations for the conduct of the election campaign by the party or candidate, should be considered and treated the case of each entity, which receives funds, whether these are also private, but who fails to spend them for the purpose of the campaign.
- 4) The income and expenses of each subject are in function of conducting the electoral campaign, a campaign which takes place and is realized in all its components before the date of the elections, i.e., before the date of April 25, 2021.
- 5) Violations should be considered, treated as such and not considered as part of financial reports, all financial transactions which are reflected in invoices dated after the end of the election process, i.e., after April 25, 2021. Bringing to attention that these declarations are in violation of tax procedures, as, according to [Instruction No. 24 dated 02.09.2008](#) "On tax procedures in the Republic of Albania" of the Minister of Finance, amended by Instruction no. 4, dated 25.01.2014, published in the Official Gazette no. 6 dated 30 January 2014, point 51.1 "*The seller issues a tax invoice and the buyer must request it at the time of the sale or performance of work or service.*"

B. EVIDENCE VIOLATIONS OF ELECTION SUBJECTS

B.I. - The first category of violations consists of explicit violations of the law, referring to the factual data of the self-declaration reports of the electoral subjects.

- 6) Four political parties, the National Conservative Party Albania, the Balli Kombëtar Party, the Balli Kombëtar Democratic Party and the People's Union of Albanian Pensioners, submitted reports to the CEC outside the format approved by the CEC, a violation which is sanctioned with a fine under Article 173, point 3 of the Electoral Code “*... Submission of reports in violation of rules and standardized formats approved by the CEC is punishable by a fine of 500,000 to 1,000,000 ALL.*”
- 7) The Movement for National Development Party gave the financial self-declaration report on October 11, 2022, in excess of the legal deadline. This legal violation is sanctioned with an administrative fine according to the provisions of article 173 point 3 of the Electoral Code “*... Failure to submit a financial report for the campaign within the legal deadline is punishable by a fine of 2,000,000 ALL*”

Independent candidates or nominated by political parties or coalitions, bear the same obligations or restrictions in terms of funding as the electoral entities that propose them. In addition to the party, every candidate who takes part in the elections must submit a financial self-declaration report which includes the income and expenses incurred by him in function of the campaign.

For the 2021 elections, it turns out that 1,166 candidates have not fulfilled the legal obligation to submit this report. The full list of candidates who have not submitted a self-declaration report can be found in Annex no. 1 attached to this request.

According to point 3 of article 173 of the Electoral Code “... *Failure to submit a financial report for the campaign within the legal deadline is punishable by a fine of 2,000,000 ALL.*”

- 8) Two political parties, one independent candidate, and a considerable number of candidates in the multi-name lists of entities, according to Annex no. 2 attached to this request, in violation of point 2 of article 92/2 of the Electoral Code have declared the acceptance of donations worth more than 50,000 ALL in cash.
- 9) In addition to the candidates who have determined to receive cash amounts, there is also a substantial number of candidates who have not specified the manner of receiving these donations, according to Annex no. 3 attached to this request. Under the conditions when this element has not been audited by the relevant auditors, the CEC will have to verify whether in the cases in question there is a violation of the provisions of law.
- 10) Also point 3 of article 92/2 of the Electoral Code determines the obligation of the candidates to open and publish, through the submission to the CEC, of the special bank account. According to this point “...*Candidates of electoral subjects may not use any other bank account, except for the declared ones, to receive donations for the electoral campaign, even for amounts smaller than 50 thousand ALL*” Referring to the accounts published on the CEC website, it turns out that only 35 candidates from the multi-name lists have declared the account number. Even for these candidates it is not clear whether the published account is an account opened specifically for the campaign or their normal account, as the auditors did not include this part in their reports.
- 11) From the comparison of data in the self-declaration reports of the candidates and the declared bank accounts, it results that 72 candidates, according to Annex no. 4 attached to this request, have received donations declared through the bank account, but have not deposited in the CEC the number of this account according to the requirements of the law.
- 12) Electoral subjects: a) The Democratic Obedience Party has declared 8 donors with amounts of 100,000 ALL each, made in cash; b) The Movement for Change Party has declared 4 donors with amounts of 75,000 ALL each, made in cash; and c) the candidate proposed by the voters, Mr. Pal Shkambi, has received a donation in cash through international money transfer companies in the amount of 102,000 ALL.

According to point 5 of article 173 of the Electoral Code “... *Acceptance of private funds worth more than ALL 50,000 through forms other than transfer to the bank account shall be punishable by a fine equal to the amount donated and forfeiture of the funds received to the CEC.*”

- 13) The balance of assets and liabilities, which is also an obligation of the parties to submit to the CEC, results in an unfulfilled obligation. As it is a report that complements the self-declaration report of political parties, it should be treated as equivalent in the adjudication of relevant administrative measures.
- 14) Article 7 point 2 of Decision no. 13, dated 06.04.2021 of the Regulatory Commission stipulates that the party financier should not be a candidate in the elections. This legal definition turns out not to have been implemented by six electoral subjects according to the list in League no. 5 attached to this request. The review of the measure of administrative sanction in this case must be judged according to the provisions of Chapter XIII of the Electoral Code. It is worth noting that this violation is attributed to both the political party and the party financier himself.

15) Exceeding the maximum expenditure limit by the Socialist Party by about 4.5 million ALL increases the need for sanctions according to the provisions of Article 92/2, point 4 of the Electoral Code.
According to point 9 of article 173 of the Electoral Code it is determined that “...*Violation of the maximum limit of expenses by an electoral subject shall be punishable by a fine of ALL 5,000,000 or a fine equal to the amount which exceeded the limit, whichever is higher.*”

16) Three political parties have spent less than the amount benefited from the state budget. Specifically: a) The Movement for National Development Party has benefited from the state budget 1,434,012 ALL and has spent 1,378,845 ALL (difference 55,167 ALL); b) The Social Democratic Party has benefited from the state budget 1,629,360 ALL and has spent 0 ALL (difference 1,629,360 ALL); c) The New Democratic Spirit Party has benefited from the state budget 2,188,832 lek and has spent 1,703,500 lek (difference 485,332 lek).
According to point 7 of article 88 of the Electoral Code “... *In the event the amount calculated in point 5 of this Article is higher than the total electoral campaign expenditures reported by the political party or is estimated as such by the CEC following independent audits or verifications conducted by it, the political party shall be obliged to return the difference to the CEC.*”
Administrative sanction, in case of non-implementation of the above obligation, further completed with the provision made in point 8 of this article “... *In the event a political party fails to enforce the provisions of point 7 of this Article, it shall be excluded from the right to benefit public funds for a period of no less than 5 years, unless it pays the dues and the fines*”
- 17) In violation of point 2 of article 92/6 of the Electoral Code, the National Conservative Party Albania did not cooperate with the legal audit, which was contracted by the CEC to audit the election campaign funds of this entity.
The audit of the Democratic Party also refers in its report that the self-declaration reports of its candidates have not been made available by this entity.

According to point 2 of article 173 of the Electoral Code “...*Obstructing or failure of the electoral subject to cooperate with the CEC auditor shall be punishable by a fine of ALL 2,000,000 to 3,000,000, and suspension of the public financing of the political party for up to 5 years.*”

- 18) The limit of payments that can be made in cash is determined by the bylaws in force in the maximum amount of 150,000 ALL.

The Socialist Party has paid in cash an invoice with a higher value than what is determined by law to be paid in cash, specifically an invoice worth 311,654 ALL. The Movement for Change party has liquidated an invoice worth 515,425 ALL without specifying the manner of payment. Also 6 candidates of the Socialist Party, according to League no. 6 attached to this request, have made such cash payments.

Instruction no. 24 dated 02.09.2008 “*On tax procedures in the Republic of Albania*” amended by Instruction no. 4, dated 25.01.2014 of the Minister of Finance, point 59.1.1 stipulates that “... *Pursuant to point 1 of article 59 of the Law, taxable persons may not carry out sale and purchase transactions between them in cash, when the value of each transaction is greater than 150 thousand ALL. Carrying out in cash and not through the transfer from the liquidator account of the buyer to the liquidator account of the seller of sale and purchase transactions exceeding the value of 150 thousand ALL, constitutes a violation for both the seller and the buyer and is punishable under Article 120 of the Law with a fine of 10 percent of the value of each transaction performed in cash.*”

B. II. - The second category of violations consists in cross-referencing the data reported by the subjects with data collected by third trusted institutional actors, which the CEC can not only have, but, in the knowledge of KRIIK, has already started a verification process. Specifically, this point includes expenditures for Media and Social Media.

- 19) Payments made to media operators, and payments made for the purpose of advertising on social media, are items that can be verified through cross-checking with the information of third, reliable institutional operators. By obtaining this information, as any interested actor can do, KRIIK has made it possible to cross-reference these data with the data declared by electoral subjects. After this process it was concluded that the data declared by the subjects with those obtained from third sources, are not the same. In both cases we are dealing with, at least, non-declaration of expenses.

- 20) KRIIK has made an approximate calculation of the costs incurred by the parties for advertising in the media, having as basic data the advertising fees published by them on the CEC website, as well as the advertising minutes reported by the AMA.

- 21) The data have been calculated and should be considered considering two important circumstances, which affect the amounts in question, and which in this case turn out to reflect the smallest amount that constitutes the difference between the declarations of expenditures by entities and the actual expenditures of considered committed by the media service providers.

22) The first circumstance is related to the fact that 21 media outlets (media service providers) did not deposit with the CEC the official advertising tariffs, in violation of the obligations set out in Article 84, point 5 of the Electoral Code. While these are OSHMA, the list of which is found in Annex no. 7 attached to this request, have broadcast advertisements.

KRIIK has performed the respective calculations, considering the cost per unit of advertising the lowest figure declared to the CEC by other media outlets, which specifically is estimated to be 1000 ALL. From the calculations for these 21 OSHMA results a total amount spent for advertising of 258,804,600 ALL, according to Annex no. 8, attached to this request.

23) The second circumstance is related to the uncertainty that KRIIK has if the amount declared to the expenses by the electoral subjects is the actual amount paid or the amount reflected in the OSHMA invoice, where the latter includes the free time of the advertisement made available according to the definitions. of point 6 of article 84 of the Electoral Code, media *is obliged to make half of the total advertising time available to electoral subjects free of charge*.

In any case, it is emphasized that the total amount, which results as the difference between what is declared by the electoral subjects and what is spent by the media, in the calculations referred by KRIIK, turns out to be the minimum value.

Referring to the calculations performed, there is a difference of at least 953,853,957 ALL undeclared. All calculations performed, the list of electoral subjects that have or have not advertised, and that have declared or not those in the submitted reports, along with the relevant values in lek, can be found in Attachment no. 9, table 9.1 and table 9.2 attached to this requirement.

24) Regarding the role and behavior of the media service providers during the election campaign, an element that should be taken into consideration and reviewed by the CEC, are the declared payments made to the media service providers by some electoral subjects, for which it is proven that no advertisement was transmitted by these media outlets for the paying entity in question. One of these cases is the payment declared in the report of the candidate Lavdim Krasniqi of the Socialist Party, for the show "Candidate" on Top Channel.

In the situation when AMA does not conduct qualitative monitoring but only quantitative monitoring of media broadcasts, it is concluded that we are dealing with a paid political advertisement, but not specified by the media as such at the time of presentation and broadcast to the public.

In this context, it is appreciated and suggested that the CEC be further deepened to understand the reason for these payments, not only to ensure transparency, but also to integrate these issues into concrete reflections / proposals for immediate legal amendments.

25) In cross-referencing the data made to verify the ads on social media, it is stated in advance that it is not clear what specifically is included in the voice declared on social media by electoral subjects (parties and candidates), as it is unspecified. While in the control conducted by KRIIK are included only the data on the advertisements made on *Facebook* and *Instagram*, since these platforms enable the publication and free access to the expenses incurred in them. Also, in the calculation made the advertisers, who have spent less than US \$ 100 on

advertising during the mentioned period, have been calculated with a minimum spending value of USD 10. This is because the expenses made below the value of 100 USD are not determined accurately, but by rank, making it impossible to record the exact value spent.

- 26) From the control of this library, and the comparison with the information that the subjects themselves have submitted to the CEC through their financial reports, it results that 3 electoral subjects, 2 political parties and an independent candidate, declare 0 expenses for social media, but according to the library of ads on *Facebook* and *Instagram* it turns out that payments have been made. Specifically:
 - a) - The Balli Kombëtar Demokrat Party, for the Facebook page of which the amount of 41,964 ALL was paid by the individual Fatmir Roshi, did not include any expenses in the self-declaration report;
 - b) - The Social Democratic Party, for the Facebook page of which the amount of 21,596 ALL was paid, did not include any expenses in the self-declaration report; and
 - c) - Independent candidate Elton Debreshi, for whose Facebook page the amount of 29,170 ALL was paid, did not declare this expense in his self-declaration report.
- 27) It turns out that 69 candidates, according to Annex no. 10 attached to this request, have declared 0 income and expenses, while according to the advertising library on *Facebook* and *Instagram*, it turns out that payments have been made for their pages, by the candidate himself or by third parties.
- 28) It turns out that 63 candidates, according to Annex no. 11 attached to this request, have not submitted a report, while according to the advertising library of *Facebook* and *Instagram* have made expenditures on these platforms.

B.III. - The third category of violations consists of cross-referencing information with reliable data collected by third actors, such as KRIIK.

- 29) In its observation action, KRIIK has focused on finding field election offices through its long-term observers. This identification, which has also been the focus of observers contracted by the CEC.
Regarding the information available on the election offices, in parentheses, it is pointed out that due to the shortcomings in the explanations in the self-declaration reports submitted by the electoral subjects, but also in the conditions of lack of a deepening by the auditors, it is not clear. the division in the declaration of the expenses made for the election office between the electoral subject and his candidate.
- 30) Calculating and considering as number of electoral offices open for an electoral subject, the sum of the number of offices declared by the entity itself with the number declared by all its candidates, results in a major difference compared to the total number of polling stations observed. on the ground, either by CEC monitors or KRIIK observers. It is emphasized that in the impossibility of further verifications, in the case of duplicate declarations this difference increases even more.

31) The number of polling stations declared by political parties is a total of 479 polling stations. Of these 426 offices were declared by the parties and 53 offices were declared by the candidates.

On the other hand, it turns out that the total number of election offices recorded in the field by observers contracted by the CEC is 660 offices, while according to the evidence made by KRIIK observers this number is 651 offices. A detailed overview of the number of polling stations for each electoral subject can be found in Annex no. 12 attached to this request.

32) KRIIK urges the CEC for an in-depth review of this discrepancy as a very useful and valuable element, which, in an analytical approach on the items of expenditure and the respective costs, would give a more complete picture of the real expenditures of related to the maintenance and normal functioning of an election office, and consequently of the electoral activity as a whole, for this vote, of a political party.

The third group-column contains the data on the basis of which the calculation of the amount actually spent is calculated. More specifically: Media where advertisements were broadcast according to AMA monitoring; Time in minutes of advertising broadcast in that media according to AMA; Average tariff applied by television for advertising (in ALL / sec) based on tariffs submitted by the media and published on the CEC website; as well as the calculation of the amount paid. In the average tariff column, given that 21 media outlets presented in appendix no. 7 above, have not submitted to the CEC the official tariffs applied by them, the minimum value of tariffs presented by other media has been applied, specifically 1,000 ALL.
